

Most Lecture Videos should have transcripts and captions which present audio content as text. Transcripts and captions are critical for people with hearing impairments, and are extremely useful for second language students, or students who wish to search for specific topics in the lectures.

In some cases, when captions were not possible to generate, there may be downloadable transcripts available.

I'm hoping that you've got a stack of notes. This should be filed and so should your marked questions. Those are what I can think of that should be paperwork that you've accumulated, and everything else I think is on Vula.
